What advice do you have for other young lawyers? Presentation goes a long way toward establishing trust with your audience, whether co-workers, clients or the court. Sloppy-looking work, however informal the assignment, puts your readers in the wrong mindset before they even read what you wrote. The little details matter more than you think they do.

What's the hot topic in your practice area? Like with many practice areas, we have been talking a lot about how to operate remotely. For example, when litigating in person isn't possible, how do you use technology to present your best case to the judge, connect with clients and conduct meaningful depositions?

What's your biggest accomplishment so far? My biggest legal accomplishment was when a judge ruled from the bench in my client's favor after hearing oral argument on my summary judgment motion.

Who inspired you to enter the legal profession or your practice area? When I was a young boy, I had two main professional idols: Michael Jordan, who played guard for the Chicago Bulls, and my mother, Laurie San Angelo, an attorney at the time and is now a Superior Court Judge in Pima County. Over time, I realized that getting paid to play sports would not be a real career option for me, so I chose Plan B and started working towards becoming a lawyer like Mom. I picked a different practice area so that it wouldn't be so obvious that I could never be as amazing an attorney as she.

What's the hot topic in your practice area? I'd call it "embracing the froth." 2020 was a weird year, and 2021 is shaping up to be a similarly weird year, with companies either desperately trying to survive or watching their valuations go parabolic—and sometimes both. Owners of companies were eager to take advantage of this strange set of market conditions through M&A and/or capital raising in the second half of 2020, and I expect this to continue in the first half of this year so long as fiscal and monetary policy remains as accommodative as it has been (or more so).

What are your career goals? As someone who graduated from law school with six figures worth of student debt, I'd like to one day be able to say that I don't practice law for the paycheck. But mostly, I want to be remembered as someone you can count on to give you good advice.

What's your favorite legal show, movie, or book? "The Wire" is the best show of all time."

Who inspired you to enter the legal profession or your practice area? My grandparents were big inspirations. My grandfather was a public servant and government lawyer. My grandmother was one of seven women in her medical school class in the 1950s. My parents lived through a revolution and came here from a place without an independent judiciary and very few political rights. All of that animated my decision to pursue election and employment law.

What's the hot topic in your practice area? In election law, whether the new Congress will re-invigorate the heart of the Voting Rights Act in response to the Shelby County v. Holder decision from 2012. The House passed an amended VRA last year. The VRA amendment will likely be back this year, so all eyes will be on the Senate. In employment law, how government and voters will address ongoing independent contractor issues in the app-based gig economy.

What's your biggest accomplishment so far? In my prior private practice, I helped defend Arizona voters' right of initiative to make laws directly and independently without the legislature. In 2016, I successfully defended the minimum wage and paid sick leave initiative, keeping it on the ballot. The voters approved and nearly one million Arizonans got a pay raise. Some got paid sick leave for the first time. In 2018, I successfully defended the clean energy initiative, keeping it on the ballot. Even though the initiative did not pass, saving the initiative allowed voters to decide. In my first year and a half working as a government attorney in civil litigation, I am happy to say I had an undefeated record.

What's your favorite legal show, movie or book? The original "12 Angry Men" remains a favorite of mine.

Who inspired you to enter the legal profession or your practice area? Raphael Lemkin. He was a Polish lawyer best known for coining the word "genocide." His story helped me understand the power of language and the law and that words alone have significant power.

What advice do you have for other young lawyers? It may be hard but be a little fearless. Whether that is agreeing to take on new tasks that you have never done before or making a pivot into a new area of law, you have to force yourself out of your comfort zone. Large gains are achieved by those willing to take risks, even when they seem daunting.

What's the hot topic in your practice area? So much of litigation is about physical presence – presence in the courtroom, before a jury, and in depositions. That presence allows us to use the physical power of our bodies to exert influence and to implement strategic decisions based on observed body language. Right now, that in-person interaction is not possible. In addition to the technical and procedural complications we are working through by being unable to interact due to Covid, litigators now have to find new ways use to achieve these goals while on Zoom.

Working with them helped me learn that I had a passion for working with businesses to get various transactions over the finish line. Because of that experience I went to law school and pursued opportunities in corporate law effect and tables.

What advice do you have for other young lawyers? Try to gain exposure to all parts of each matter you work on. For example, if you work in corporate and mergers and acquisitions, ask to see all parts of the transaction, not just the schedules/data room, or if you work in litigation, try to gain exposure to how the lead attorneys handle and manage cases and clients. I found a huge benefit to just "being in the room" and understanding how the entire process works. Second, and tied to the first point, is to try to find someone at your job who can mentor you and push you to get that exposure. I've been fortunate to work with attorneys at various stages of my career who invested their own time (bringing me in on calls/pitches/negotiations) in my success.

What's the hot topic in your practice area? Finding creative solutions in M&A transactions and commercial agreements that would be less standard absent Covid, and revisiting "stock" language (force majeure/assignment etc.) in commercial contracts in light of a turbulent business landscape.

What's your favorite legal show, movie or book? It's hard to top "My Cousin Vinny"

Who inspired you to enter the legal profession or your practice area? After I finished college, I worked as a legal assistant for a solo practitioner named Sid. Sid was a great mentor. He included me in developing strategy for his cases, taught me how to interview witnesses (and allowed me to interview many witnesses), and taught me about his practice areas. I was hired as a legal assistant, but the experience was a lot like being a student. I loved it and decided to become a lawyer.

What advice do you have for other young lawyers? Surround yourself with people who care about your development. I am fortunate to be able to work with so many talented lawyers who give me opportunities to shine and who go out of their way to mentor me. It can be difficult to get feedback, so finding good mentors is important.

What's the hot topic in your practice area? Fraudulent transfer claims, which basically are an attempt by a bankruptcy trustee or creditor to avoid a transfer of money or property by a debtor. These types of claims have become much more common recently as insolvency has become more prevalent. I represent financial institutions, judgment creditors, and judgment debtors, and fraudulent transfer claims have been a large part of my practice. I anticipate that fraudulent transfer lawsuits will continue to trend upward.

What's your favorite legal show, movie or book? It's not exactly a legal show, but "It's Always Sunny in Philadelphia" has a character, Charlie Kelly, who has no legal training but aspires to be a lawyer with an expertise in bird law. He often encounters "real" lawyers in the show, and his interactions with them are hilarious.

Who inspired you to enter the legal profession or your practice area? My 7th grade English teacher, Ms. Glenn. She had us participate in a mock trial and chose me to play the defense attorney. I remember staying up all night preparing my opening and closing arguments, trying to justify why my client should be acquitted. I had so much fun with the process – in large part because of Ms. Glenn's unwavering enthusiasm – that I knew I wanted to be in real courtrooms one day.

What advice do you have for other young lawyers? Don't be afraid to learn and expand into different areas of the law. Expertise in niche areas will come with time, but the early days are good for seeing what's out there. Also, find and engage in pro bono cases with regularity. It has always amazed me how relatively minimal effort from a lawyer can make a truly monumental difference in the life of a person in need.

What's the hot topic in your practice area? One of my areas of practice is higher education law, including in issues dealing with Title IX. Unsurprisingly, guidance as to Title IX's enforcement changes between presidential administrations. It changed in significant ways between Presidents Obama and Trump, and I expect it will change again under President Biden. Getting up to speed quickly with the new administration's guidance will be important for everyone.

What's your favorite legal show, movie or book? "To Kill a Mockingbird" was my first love in terms of books involving lawyers and legal proceedings. Atticus Finch was incredible. More recently, I've enjoyed reading about the legal careers of various American presidents, including my personal hero, Abraham Lincoln.
